Further to your telephone conversation, I enclose herewith an Ordnance Survey extract indicating an area edged red that I wish excluded from the Urban Open Space policy designation by reason of the existing built development, the expansion of the School and the long dis-used Tennis Courts and classroom.

I have edged blue an area of land, formerly owned by the Sisters of St. Paul, now developed with two houses, and which is still within the Urban Open Space policy allocation area coloured green. This is obviously incorrect now, given the grant by your Authority of that Planning Permission and there should be a consequential amendment.
