About FACS

FACS - Free Access for County Sports people

Under Spelthorne Borough Council's Free Access for County Sports people (FACS) scheme, county sports people who live in Spelthorne may be eligible to use a variety of leisure facilities free of charge.

Facilities included in the scheme:

- Spelthorne Leisure Centre
- Sunbury Leisure Centre
- Bowling greens

Who can apply?

General conditions

- FACS scheme members must be of County Standard or above in their sport and provide a supporting letter from an official of their governing body or coach.
- FACS scheme members must be residents of Spelthorne
- FACS scheme members will be restricted to using facilities that complement the sport that they represent their County in.
- all applications will be verified before the FACS membership is confirmed
- Spelthorne Borough Council reserve the right to terminate membership, should any breach of the FACS scheme conditions occur, or should reasonable grounds be given by a Facility Manager
- Spelthorne Borough Council reserve the right to alter the conditions of use at any time

Use of Facilities

General conditions

- FACS scheme members must show a valid Everyone Active card on every visit to the facility
- FACS scheme members can only use facilities if they are available and the use does not prevent the use by a paying customer
- FACS scheme members cannot book facilities in advance

Leisure Centre conditions

- free use is limited to off peak times, from 9am-5pm Mondays to Fridays and all day Saturdays and Sundays. Members must pay full fees for any facilities used outside of these times
- if the gym at either site is to be used, the member must first complete and pay for a full gym induction
- if the FACS member is under 16, the gym at either site can only be used if accompanied by a fee paying adult
