
Local Government Reorganisation















What is Local Government Reorgansation

In Surrey, some services (like education, adult and children's social care and roads) are run by the County Council, while others (like bin collections, planning, and housing) are run by your local Borough or District Council.

But the national Government wants to simplify that system - combining councils into unitary councils so that one council delivers all services in your area.

> This is called Local Government Reorganisation.

Background

 on 16 December 2024, Central Government published a White Paper on the decentralisation of government power to local or regional authorities

Surrey selected for the 'first wave' of reorganisation and devolution

invited to submit an interim proposal to Government by 21 March

final plan to be submitted by 9 May 2025









Part A - key headlines

11 D& Bs and Surrey CC agree:

- commitment to LGR to improve efficiency and unlocking devolution
- ambition to create a Mayoral Strategic Authority for the area and opportunities it would bring:
 - funding opportunities, saving efficiencies, wider approach to service delivery and accountability
- challenges:
 - disruption to social care services, dealing with council debt, staff retention and responding to Surrey's housing crisis







Part B - key headlines

- Case for two unitary authorities:
 - greater economies of scale
 - reduces complexity of splitting services, such as social care, across three authorities

- Case for three unitary authorities:
 - balances financial considerations with residents' sense of place
 - more localism and resident engagement

Government may choose a single, two or three unitaries










Geography - 1.1: East/West

Spelthorne, Guildford, Runnymede, Surrey Heath, Waverley and Woking.














Geography - 1.2: East/West

South-west Surrey

Guildford, Waverley, Woking, Surrey Heath (Population 470,000 residents)










Geography - Option 3: three unitary approach















Three unitary approach - the benefits

- maintain a **strong connection** to **local identity and place** while also meeting the aims and objectives of local government reorganisation
- enable communities to continue to feel that they are represented and that their unique **social**, **cultural**, **and economic characteristics** are reflected in local governance
- naturally align with economic **geographies** and commuting patterns to drive local economic growth









Councillors and elections

 both proposals recommend new unitary councils hold 'all-out' elections every four years

Spelthorne currently holds elections every 4 years, some are three years

up to three Councillors per ward

shadow Cabinet elections in May 2026









Implementation

Phase 1: Pre-planning (inc. government-led resident consultation) - May to October 25

- Phase 2: Planning and preparing Sept 25 to May 26
- Phase 3: Shadow governance May 26 to March 27
- Phase 4: Implementation April 27 onwards









Next steps

- Government still working with D&Bs and County Leaders
- resident engagement
- councils continuing assessing proposals
- Spelthorne Full Council meeting 6 May to discuss final proposal
- final plan must be submitted to Government by 9 May 2025
- Government consultation (late summer/autumn)
- shadow Cabinet elections in May 2026
- decision reached and unification begins May 2027
