We received money from a variety of sources:

- · Council Tax £6.1m
- fees and charges for services provided £6.8m
- the Government gave us a general grant of £0.8m towards delivering services. They also gave grants for specific services for example they met the cost of Housing Benefit payments £23m
- we collected £35m of Business Rates on behalf of the Government and we received back £4.7m of that

A few money facts

- the Council had £20m cash-based reserves (money set aside) as at 31 March 2008.
- we collect Council Tax for Surrey County Council, Surrey Police and Spelthorne Council. Spelthorne Council only keeps 12p in every pound.
- we earned an interest income on our reserve balances in 2007/08. This contributed £1.5m towards funding the cost of services.
- we have to keep reserves, in case of emergencies, as money put aside to cover unexpected expenditure.
