Introduction

Part 2 supplements the Infrastructure Delivery Plan (IDP) by analysing individual site allocations in greater detail. This involves highlighting specific infrastructure requirements that have been identified and that can be included as a means of securing these through developer contributions.

Developer Contributions

Developer contributions are secured by way of the Community Infrastructure Levy (CIL) and s106 legal agreements. In certain cases, s278 of the Highways Act can be utilised to secure agreement on highway matters between the County Council (as the Highways Authority) and the developer.

CIL

CIL is a mandatory contribution per residential development based on increase in floorspace. Spelthorne Borough Council has been collecting CIL since 2015 and based on current projections it is anticipated that the Borough will receive circa £1m per annum of Strategic CIL over the Plan period.

S106 agreements

Prior to September 2019 there were pooling restrictions in place which limited the ability to secure obligations through s106 agreements. These restrictions have now been lifted and this provide the opportunity for CIL and s106 agreements to be used in conjunction with each other as a means of securing betterment from development.

Allocations of development

The table below sets out the proposed site allocations and the development yield anticipated to be achieved. This allows evidence-based assumptions to be made in regard to costs for infrastructure funding where these have been identified. As derived from the IDP, healthcare costs and identified police contributions have been included within this Table. Whilst education funding requirements have not been set out, there remains scope for requirements for contributions towards these to be included and for funding to be secured through s106 and/or CIL where appropriate.

From the above, the total estimated healthcare contributions as derived from the evidence work produced by Co Plug equates to circa £10,641,900.

This funding would help to close the gap identified in the IDP. However, whilst the intention is to secure this money through s106, there is the possibility that there could be a shortfall which could be made up through the use of Strategic CIL. Given that the funding from the NHS can only be up to a maximum of 66% it is likely that CIL will be required to 'top up' in order to meet identified requirements.

As such, there is the potential that an amount of CIL could be set aside to help make up this shortfall. However, the apportionment of CIL is directed by the relevant task group and there are a range of priorities and other projects that compete to secure some of the available CIL monies.

In addition, the identified funding requirements for the Police that have been provide equates on a per development basis to meet the figure set out in the IDP.

Additional funding could be secured for education and highways improvements for SCC if, and when this information is made available. Once the relevant traffic modelling work has been undertaken, any identified costs associated with potential mitigation, if necessary, can be included within the IDP.
