## Introduction

Spelthorne Borough Council introduced Community Infrastructure Levy (CIL) in April 2015. CIL is chargeable on certain types of residential development, purpose-built student accommodation, and large, out-of-centre retail (full details can be found in the published CIL Charging Schedule).

Since 2015 in excess of £9m has been collected in CIL receipts. This report will provide further information on monies collected, spent, and committed within the previous financial year ("the reported year").

This IFS will cover the reported year April 2022 – March 2023.

As per requirement 121A of the CIL Regulation, the Annual IFS should include:

- Infrastructure list
- CIL report
- Section 106 report

This report will provide the information required under requirement 121A of the CIL Regulations.

## What is CIL and how is it allocated?

The purpose of CIL is to allow the Council to raise funds from some forms of new development to help fund the infrastructure required as a result of growth and is needed to mitigate the impacts of new development.

There are three elements to CIL: Strategic, Local, and Administrative. The percentage breakdown is as follows:

- Strategic CIL 80%
- Local CIL 15%
- Administrative Costs 5%

The Council aims to utilise CIL in conjunction with infrastructure providers to deliver improvements Borough-wide. All CIL funding is allocated through a competitive bid and review process.

Through work on the Local Plan and the Infrastructure Delivery Plan (IDP), officers consult and work with key infrastructure providers, and require them to identify areas where there are, or they foresee funding gaps. Where appropriate, these providers are encouraged to bid for CIL funding. Due to the large scale, and strategic nature of projects brought forward by the key infrastructure providers, these bids tend to fall under the 80% Strategic element of CIL. Such providers include (but are not limited to) Surrey Highways, Surrey Education, the Integrated Care Systems (ICS), the National Health Service (NHS) and Surrey Police.

An annual Strategic CIL Spending Round, with a deadline of 30<sup>th</sup> June, welcomes applications of the above nature. The CIL Task Group considers the applications received and makes recommendations to the Environment & Sustainability (E&S) Committee, who are the final decision maker.

Local CIL, which accounts for 15% of receipts collected, is also allocated through a competitive bid process. Local CIL can be used towards more localised projects, which are required to be secured in the communities where development has taken place.

Examples of the types of projects Local CIL can be used for are:

- Community centre improvements,
- · Community notice boards,
- Bike shelters and;
- Local signage.

The Council expect applications to come from statutory infrastructure providers and not-forprofit organisations such as state schools, community groups and registered charities for projects that demonstrate a wider community benefit.

Local CIL is awarded by Local CIL Spending Boards. These Boards will convene once per annum, in the Spring, to consider and decide on bids received prior to 31<sup>st</sup> March.

The remaining 5% of CIL receipts are retained towards administrative costs, as required by the Regulation.

#### Infrastructure List

Forming a part of the emerging Local Plan's evidence base, an Infrastructure Delivery Plan (IDP) has been published, identifying areas where additional funding needs have been identified, and may be sought through CIL and/or S106 contributions.

Through consultation with key infrastructure providers, evidence was provided to demonstrate the potential funding gaps over the Local Plan 15-year period. Using the figures provided, the IDP Part 2 lists required developer contributions by site, in order to mitigate the funding gap and allow provision for the infrastructure identified and required. Applications for CIL funding will be assessed against the infrastructure needs identified in the IDP.

A number of CIL commitments were made during the reporting period. The following projects are either part or fully funded by Strategic CIL (full information on funding is included in the report under the CIL section):

- Spelthorne Borough Council Playing Pitch Upgrade (Boroughwide)
- Surrey Police Community Engagement Van
- NHS Reconfiguration of Sunbury Health Centre to create additional clinical space

The first Local CIL Spending Round was launched in September 2021, with an application deadline of March 2022. Applications were received from a range of bidders, including local charities, school, and sports clubs.

The decision-making process took place over the summer, with awards announced in July 2022. The following projects are either part, or fully funded by Local CIL (full information on funding is included in the report under the CIL section) -

#### Note 1 - Parish Councils

As defined in Part 7 of the Regulations, 'Application of CIL' a local council means a parish council. As Spelthorne does not have any parish councils, Local CIL is allocated in accordance with regulation 59F.

## CIL Spending on Infrastructure (Section (h) expanded)

Within the reporting year, a total of £939,538.88 of Strategic CIL receipts have been allocated to essential infrastructure projects in the Borough.

## Spelthorne Neighbourhood Services - Leisure & Community Development - Playing Pitch Upgrade

This bid sought £68,050.00 towards a project to make improvements to Local Authority owned, community accessible grass football pitches within Spelthorne to ensure sufficient good quality pitches are available to meet the boroughs needs.

The Spelthorne Playing Pitch Strategy (2019) assessed the quality of and the supply and demand for all community accessible football pitches in the borough. The strategy identified that there is currently a deficit for most types/sizes of football pitches in the borough and that this deficit is likely to increase with the expected rise in population in the coming years.

This bid was successful, and the pitch locations are as follows;

#### **Surrey Police – Public Engagement Van**

This project sought funding towards a new, fully electric public engagement van to be used for a variety of police engagement purposes and during operational policing.

According to Surrey Police, public engagement is a key priority for the Force and their local policing teams. The provision of a public engagement van will vastly increase public visibility within the borough and provide advantages, from increased officer efficiency, to improved

visibility of the force in the local community.

This application was successful, with £59,964.88 of Strategic CIL being committed to the project.

## NHS - Reconfiguration of Sunbury Health Centre to create additional clinical space

This application sought £811,525.24 for a programme of works to Sunbury Health Centre. The aim of the project is to facilitate population growth in Spelthorne and provide better patient care for residents now and in the future.

The works involve internal reconfiguration of the Centre, including the conversion and remodelling of existing ground floor administrative space to create clinical rooms, and the subdivision of existing large clinical space to create an additional 4 clinical rooms. The increase in capacity to the Centre would allow for an additional 480 clinical appointments per week.

## **Local CIL Bids**

The first Local CIL Spending Round was launched in September 2021, with an application deadline of March 2022. Applications were received from a range of bidders, including local charities, school, and sports clubs.

The full list of schemes to which Local CIL was allocated can be found on Page 5 of this report.

During the reported period the following CIL payments were made to completed Local CIL schemes;

Thamesmead School, Shepperton - Installation of outdoor gym, additional sports equipment, line marking and seating areas

£40,000 Local CIL was paid towards the above scheme to promote healthy living and exercise. The improvements to the school's outdoor space was to assist students with behavioural & mental health issues.



## WR Sports Club, Ashford - Swing for children's playground

£5,000 of Local CIL was committed to the installation of play equipment for children. This equipment is accessible to the general public. The project came in under budget, with the total cost coming in at £4,101.24.

## S106 Spending on Infrastructure (Section (i) expanded)

Further information on S106 spending (as listed in Section (i) is as follows;

• Annual Maintenance Costs for Hithermoor - £ 56,014.92

This money was spent on annual tree maintenance and removal of brambles to enhance and restore the biodiversity of the site. A number of bird boxes were installed on site to promote biodiversity.
